Conservation Program - Includes the ownership of 411 acres of woods and farmland in North Bennington, Vermont and its environs, widely used by community members for walking, running, birdwatching, and cross-country skiing. The Fund has set aside monies for conservation of important lands in the Village of North Bennington, and holds conservation easements on land. **At the end of the fiscal year, The Fund acquired all remaining interests in The Left Bank, LLC to become its sole owner. The Left Bank is an 1864 High Victorian brick building that served as a bank for nearly 150 years. In 2013 The Merchants Bank donated the building to The Fund and to the Preservation Trust of Vermont, both nonprofit organizations. Their primary goal was to redevelop the property to increase the vitality of the Village's Main Street. The office spaces were remodeled and are currently used for business and professional offices, while the former lobby is now host to yoga, music, and movement classes, as well as being available for special events and educational uses.


