ment and regulation of automobiles and other motor vehicles on the streets of said village, with respect to speed, parking and the general management of said vehicles upon said streets, and through its corporation attorney or police officers to prosecute all violations of such regulations before the Bennington municipal court, and all fines and costs collected by said court for violations of such regulations shall be paid into the treasury of said village of Bennington.

SEC. 2. Section 1 of this act shall take effect when ratified by a majority of the legal voters residing in said village of Bennington present and voting at the annual meeting of said village, or at any special meeting thereof duly called for that purpose. In the notice of the warning of such meeting there shall be

inserted an article as follows:

"To see if the village will vote to approve, ratify and adopt an act of the General Assembly of 1925 entitled 'An act to amend section 44 of No. 226 of the acts of 1884 as amended by No. 189 of the acts of 1923, relating to the charter of the village of Bennington.'"

In case such voters shall ratify this act, it shall take effect

immediately upon such ratification.

Sec. 3. Section 2 of this act shall take effect from its passage.

No. 167.—AN ACT TO EXTEND THE BOUNDARIES OF THE NORTH BENNINGTON GRADED SCHOOL DISTRICT.

It is hereby enacted by the General Assembly of the State of Vermont:

Section 1. The boundaries of the North Bennington Graded School District are hereby extended so as to include all of the town of Bennington which is included within the limits of the incorporated village of North Bennington.

No. 168.—AN ACT TO AUTHORIZE THE BRANDON TOWN SCHOOL DISTRICT TO ISSUE BONDS.

It is hereby enacted by the General Assembly of the State of Vermont:

Section 1. The Brandon town school district is hereby authorized and empowered by majority vote of the legal voters
