Conservation Program - Includes the ownership of 416 acres of woods and farmland in North Bennington, Vermont and its environs, widely used by community members for walking, running, birdwatching, and cross-country skiing. The Fund has set aside monies for conservation of important lands in the Village of North Bennington, and holds conservation easements on land. During the year, the Fund purchased a 5-acre parcel. The Left Bank property, which was acquired and renovated as a means of enhancing the vitality of the Village's Main Street, was rented all year.

Art Collection - the Fund maintains a collection of historic and contemporary photographs of the Village of North Bennington, VT. The Fund makes digital images of the photographs available for viewing on its website. This year the Fund added an oil painting by Frank Howard to the art collection.
